What is a Smart Card?



- **Smart cards look like a credit card but contain an embedded microprocessor and memory offering advanced encryption, security and information storage.**
- **This smart card advantage allows the Campus Card to perform numerous services now, and is expandable to even more functionality in the future.**
- **For example the InstaPayment Campus Card is able to store:**
 - **Cash transferred to Campus Card by parents**
 - **Emergency contact information**
 - **Parent contact detail (names, numbers, etc.)**
 - **Parental purchase authorization**
- **The Campus Card System system provides significant benefits to both schools and parents.**

Significant School Benefits



- *Cashless system.* Students use the Campus Card for all school transactions such as lunch, library and field trips. Less cash reduces crime and theft, and minimizes student's ability to use cash to buy non-desirable products.
- *Improved Operational Efficiencies.* Considerable reduction in time for cafeteria checkout, supply planning and attendance record keeping.
- *Improved cash flow.* No waiting for mail or checks to clear. Funds are electronically transmitted to school bank accounts.
- *Emergency Alert.* Our integrated "Emergency Alert System" enables school authorities to instantly send voice, text and Email messages to all parents notifying them in a single action.
- *Automated Reimbursements from the National School Lunch Program.* Campus Cards automatically generates reports needed for NSLP reimbursements

School Benefits (cont)



- *Improved material supply chain.* Food vendors can have real-time feedback of product demand and consumption for supply planning and electronic order entry.
- *Eliminates discrimination.* Free/reduced lunches are recognized only through the system, ensuring student's privacy.
- *Eliminate PCIDSS Security Risks.* New credit card security rules make improper handling of credit card information very risky for schools.
- *No cost to schools.* InstaPayment receives revenue via a 'convenience / reload fee', paid only when electronic funds transfer to the student's I.D. cards. Additionally Schools do not pay any merchant fees when the Campus Card is used.

Significant Parental Benefits



- ***Cashless system.*** Parents transfer funds to students cards via website eliminating the need for cash on Campus, removing the number one reason for vandalism on school campuses.
- ***Purchase reporting.*** Parents are provided weekly on-line statements identifying the purchases students made via the Campus card. Reports include “Lunch accounting and nutritional reporting” enabling parents to monitor eating *habits*.
- ***Increased Parental Control.*** Parents can prohibit purchases of certain foods (i.e. vending machine purchases) for nutritional purposes or foods the child may trigger allergies.
- ***Immediate Notification In Emergencies.*** Parents can elect the method or methods they would like to be notified in the case of a school emergency.
